

### **Correction of Error on Five-Year Treasury Yield**

On November 7, 2013, the OCC and Federal Reserve issued revised macroeconomic scenarios for the 2014 Dodd-Frank Act Stress Test to correct a minor computational error for the projections of the five-year Treasury yield in the *Baseline* and *Adverse* scenarios. The Severely Adverse scenario was unchanged.
